In accordance with the provisions of Articles 12 and 78 of the Law on Associations (Official Gazette RS, No. 51/09) and Article 16 of the current Statute, at the Extraordinary Assembly of the Association "European Movement in Serbia - Leskovac" held on May 19, 2018 in the PKS Regional Chamber of Commerce of Jablanica and Pcinja Administrative District in Leskovac, Stojana Ljubica 12, Leskovac, was adopted - in the consolidated text - the following amended and supplemented

STATUTE

I GENERAL PROVISIONS

Article 1

Association "European Movement in Serbia - Leskovac" (hereinafter: Association) is an independent and voluntary association of citizens established for an indefinite period as a non-profit, non-governmental and non-party organization.

Article 2

The name of the Association is: European Movement in Serbia - Leskovac.

The abbreviated name of the Association is EMinS Leskovac.

Article 3

The Association has its head office in Leskovac, Stojana Ljubica Street 12/6.

Article 4

Association achieves its goals in the area of local sustainable development and acts on the territory of Serbia.

Article 5

The association has a circular seal and is written on the periphery by Cyrillic "EUROPEAN MOVEENT IN SERBIA - LESKOVAC", and in the central part of the seal, also by Cyrillic, the word "EPuS" is written on the diagonal.

II VISION, MISSION, OBJECTIVES AND OPERATION OF THE ASSOCIATION

Article 6

Members of the Association are gathered by a shared vision based on individuality, personal freedom, proactivity, innovation and reciprocity, as the fundamental values on which they form a society in which the life prospects of anyone are as large as possible.

The key challenges to which the members of the Association give an answer are:

1. To release the potential of an individual in conditions of systemic transition.

- 2. To build a globally competitive local environment.
- 3. To build local capacities which provide the benefits of accession negotiations and the country's membership in the EU.

The mission of the association is to provide the best support to social actors in the liberation, promotion and realization of the individual's development potential at the local level.

Members of the Association are directed towards meeting the need for freedom, competence, connectivity and entertainment.

Members of the association create value for their users by developing and realizing a set of: a) primary activities - service design, knowledge management, delivery management, evaluation and dissemination and clustering; and b) auxiliary activities - infrastructure, human resources, information and design.

Article 8

The goals of the association are:

- 1. To influence that the potential of young people, ie. of the coming generations, understands, improves and realizes as the greatest strength of local development dynamism based on the development approach to young people, especially to youth entrepreneurship.
- 2. To contribute to the existing tendency of people for the implementation of universal rules of behavior (respect for others', freedom of decision-making, responsibility for commitments), market coordination, democratization, community openness and the development of a culture of diversity effect into the globally attractive local life.
- 3. To contribute to the broadest affirmation and consistent application of universal, human principles of freedom, justice, fundamental human rights, including gender equality and non-discrimination, morality and democracy, and on that basis, establish a democratic rule of law and full protection of human rights and rights of national minorities in Serbia.
- 4. To promote the vitality of the European value framework through the contribution to the process of Serbia's accession to the EU, identifying and maximizing local benefits from this process, especially from the aspect of decentralization and regionalization, establishing local ownership on relevant concepts, approaches, contents and practices from the EU, as well as through presentation of development potential of Leskovac from the time of its europeanization as "Serbian Manchester".
- 5. Build the possibilities of modern, global development trends ("entrepreneurial society", "knowledge society", "information society", "creative economy", "green economy" etc) into local life and realize them.
- 6. To dynamize inclusive development, in particular by advocating the development of the social economy, improving relevant public policies and practical action in the field of women's entrepreneurship and employment of long-term unemployed, persons with disabilities and Roma, and improving the quality of life of vulnerable and marginalized groups, including those suffering from the most serious diseases, old and exhausted.
- 7. To contribute to the improvement of the education system in Serbia, especially through the development of non-formal education.

- 8. To contribute to the promotion of health as a multidimensional phenomenon which implies the establishment of a dynamic balance in the physical, mental and social integration of the individual and his environment.
- To contribute to sustainable spatial development, as a concept that aligns both social and economic requirements within a territory with its ecological and cultural functions, strengthens local and regional democracy and enhances social and territorial cohesion.
- 10. To contribute to preserving the biological balance through the prevention of environmental threats, i.e. providing a healthy environment as a basis for the preservation of human existence, the healthy development of society and an important factor in the quality of life of each individual.
- 11. To develop and activate the potentials of the "Activator" cluster.

In order to achieve the stated goals, the Association will carry out the following activities:

- 1. Capacity building human, organizational and institutional.
- 2. Public advocacy of relevant concepts, approaches, contents, models.
- 3. Non-formal education activities.
- 4. Research activities.
- 5. Information activities, including e-information to the public.
- 6. Promotional activities.
- 7. Activities of psycho-social support to vulnerable and marginalized groups.
- 8. Development and implementation of entrepreneurship training programs, professional practice and mentoring / coaching, as well as other necessary nonformal education programs.
- 9. Transfer of knowledge, especially in the interactive mode (workshops, interactive lectures, discussion groups, etc.), directly and in electronic form.
- 10. Organizing public events press conferences, meetings, info-sessions, panels, panels, round tables, debates, promotion, consultations, seminars, conferences and other forms of informing and involving social actors in the public decision-making process.
- 11. Printing and publishing relevant (professional, 'policy', informative, affirmative, promotional) contents, including e-production.
- 12. Lobbying in the process of innovating public policies.
- 13. Mediation in transforming relevant needs in demand (for services of entrepreneurial support, monitoring of reform changes, etc).
- 14. Connecting and networking individuals, groups and institutions, both nationally and abroad.
- 15. Organizing cultural and artistic events.
- 16. Designing, developing and participating in the functioning of innovative organizational mechanisms in the form of multisectoral strategic partnerships, consortia, associations, movements, clusters, collaborative groups, networks, including activities within NEMinS.
- 17. Managing the cluster «Activator» as a management organization.

The association establishes contacts and cooperates with other associations and organizations in the country and abroad, especially with the European Movement in Serbia.

The association can join international associations with similar goals, as decided by the Assembly, with the prior written consent of the European Movement in Serbi

III MEMBERSHIP

Article 11

Members of the Association may be domestic and foreign legal and natural persons who accept the goals and Statute of the association.

The decision on admission to membership is made by the Executive Board within the recommendations of two members of the Association.

Membership is obtained by signing an application form.

Article 12

The Association consists of:

- Individual members,
- Collective members organization, company or institution,
- Associate members organization, company or institution without the right to vote in the Assembly,
- Honorary members individuals and organizations who have contributed to achieving the objectives of the Association.

Article 13

A member of the Association may withdraw from membership by giving a written statement of withdrawal.

A member may be excluded from the Association if his actions violate the provisions of the Statute and other general acts, due to longer inactivity or non-payment of membership fee.

The Executive Board of the Association decides on exclusion from membership and delivers a reasoned decision in a written form to the excluded member.

On the decision on exclusion, a member may appeal to the Assembly of the Association within 15 days after receiving the Decision of the Executive Board.

The final decision is taken by the Assembly at the next session.

Article 14

A member of the Association is entitled to:

- Participate equally with other members in achieving the goals of the Association;
- Directly participate in decision making at the Assembly of the Association as well as through the organs of the Association;
- Elect and be elected to the organs of the Association;
- Be timely and fully informed about the work and activities of the Association;
- Actively contribute to the objectives of the Association;
- Participate in accordance with the interest in the activities of the Association;
- Performs other tasks entrusted to him by the Executive Board;
- Pay membership fee.

IV BODIES OF THE ASSOCIATION

Article 15

The bodies of the Association are:

- 1. Assembly
- 2. President
- 3. Vice President
- 4. Secretary General
- 5. Executive Board
- 6. Supervisory Board

Article 16

The Assembly of the Association consists of all its members.

The Assembly can be regular and extraordinary.

The regular assembly meets once a year.

The Extraordinary Assembly meets as necessary, and on the reasoned written request of one third of the members, the President or the Executive Board.

Article 17

Assembly:

- Brings the Statute:
- Adopts and changes the Statute;
- Adopts the annual work plan and program of the Association;
- Elects and dismisses the President, the Vice-President, the Secretary-General, the members of the Executive Board and members of the Supervisory Board;
- Consider and adopt the Report on the work of the President and the Executive Board;
- Review and approve the financial plan, the final account and the report of the Supervisory Board;
- Decides on the proposals of the bodies or members of the Association;

- Decides on joining the Association with broader forms of citizen organizations and international organizations;
- Decides on appeals against the decisions of the Executive Board;
- Decides on the amount of membership fees

The Assembly decides validly if more than half of the members are present.

The Assembly decides by majority vote of the members present.

Article 19

The President of the Association is elected by the Assembly.

President:

- Represents the Association in the country and abroad;
- Presides the Assembly of the Association;
- Presides the work of the Executive Board.

The mandate of the President is two years.

In the event of the President's preventing, or in agreement with him, the work of the association is managed by the Vice President.

Article 20

The Executive Board is the Executive Body of the Association.

The Executive Board ensures the implementation of the objectives established by the Statute and the decisions of the Assembly.

The Executive Board consists of the President, Vice-President, Secretary General and members (two members), elected and revoked by the Assembly.

The mandate of the Executive Board members is two years.

Executive Board:

- Adopts the Rules of Procedure;
- Manages the work of the Association between the two sessions of the Assembly and makes decisions for achieving the goals of the Association;
- Organizes regular activities of the Association;
- Proposes to the Assembly access to broader forms of citizen association and international organizations;
- Make decisions and entrust certain tasks to individual members;
- Make decisions on disposing of funds of the Association;
- Proposes the initiation of a procedure for amending the Statute;
- Make a decision on the appointment of the members of the Council in accordance with provision 23 of this Statute.

The Executive Board decides validly if more than half of the members are present, and the decisions are made by the majority of the votes of the present members. In the case of an equal number of votes, the President's vote shall be decided.

Article 21

The Secretary General represents the Association in Legal Traffic and has the rights and duties of the Financial Inventor.

The Secretary General is concerned about the proper functioning of the Association's work, especially on the implementation of decisions of its bodies, as well as on the implementation of program principles and goals.

The Secretary General manages the work of the office, manages material and financial operations, concludes contracts and takes legal and other actions related to the realization of the established financial obligations of the Association.

The Secretary General ensures that records of the work of all bodies of the Association are kept.

The mandate of the Secretary General is two years.

Article 22

The Supervisory Board monitors the financial performance of the Association and submits a report to the Assembly.

The Supervisory Board has three members.

Members of the Supervisory Board are elected by the Assembly.

Members of the Executive Board can not be members of the Supervisory Board.

The mandate of the members of the Supervisory Board is two years.

Article 23

The Executive Board may establish an Association Council as a consultative body composed of eminent persons and experts in different areas of social life.

Members of the Council monitor the work and activities of the Association and provide suggestions for their improvement and achievement of the goals of the Association.

V FUNDING OF THE ASSOCIATION

Article 24

The activities of the Association are financed by:

Membership fee;

- Donations and gifts;
- Competition for projects with state authorities or other foundations and organizations;
- From other sources in accordance with the law.

The Association acquires funds by performing economic activities:

70.22 Consultancy activities related to business and other management,

whereby the association will also engage in other activities to the extent necessary for achieving the objectives of the association, such as:

- Web portals;
- Information service activities elsewhere not mentioned;
- Legal jobs;
- Accounting, bookkeeping and auditing;
- Activity of advertising agencies;
- Market research and public opinion polls;
- Translation and interpretation services;
- · Activity of communication and public relations;
- Specialized design activities;
- The activity of the temporary employment agency;
- Combined office and administrative services;
- · Research and development in social sciences and humanities;
- Other education;
- Supportive educational activities;
- Performing art;
- Art education;
- Artistic creation;
- Other unlisted social security without accommodation.

The Association may also perform other economic activities that generate profit and which are in accordance with its objectives. Profit realized in this way, the Association will use exclusively for achieving its goals, including the costs of the regular work of the Association and its own participation in financing certain projects.

The activity referred to in paragraph 1 of this Article shall be entered in the Register of economic entities and only after the registration can be performed.

Article 26

The Association is responsible for its obligations solely with its assets.

Article 27

Assets of the Association can be used only on the basis of financial plans by the decision of the Executive Board.

Funds are on the current RSD and foreign currency account of the Association.

The Supervisory Board controls the use and disposal of the funds of the Association.

Article 28

The work of the Association is public.

The Executive Board ensures regular reporting of membership and the public about the work and activities of the Association, directly or through the media.

Article 29

The decision to terminate the existence of the Association shall be made by the Assembly.

In the event of termination of the Association Assembly decides on the disposal of assets and only to national non-profit legal entity which is established for the purpose of the same or similar objectives as an association. If this decision is not made, the Association's assets belong to the Assembly of the City of Leskovac which can be used to support related organizations in its territory.

Article 30

The decision on status changes in accordance with the Law on Associations is passed by the Assembly.

Article 31

The proposal for amendments to the Statute of the Association may be given by one third of the members, the Executive Board and the President.

The decision on amendments and additions to the Statute of Association is passed by the Assembly.

Article 32

This Statute shall enter into force on the day of its adoption by the Assembly of the Association and shall be applied from the day of its registration in the register with the competent authority.

Article 33

Any provisions not regulated by this Statute shall be subject to the provisions of the Law on Associations.
